#### Fixed Fee Arrangements

We can represent you under a fixed fee arrangement, depending on the complexity and duration of your case. Please contact us to discuss whether we may be able to offer a fixed fee in your case.

# What is included in the fee estimates above?

- Discussing your circumstances to establish the most appropriate application to make and advising on viable options
- Considering documents you have provided to us we anticipate this will take between 4 and 6 hours depending on the amount of documents provided
- Where necessary, helping you obtain further evidence (such as medical records and bank statements), including taking statements of any witnesses.
- Emails to and from you, phone calls to and from you and meetings
- Taking your instructions and providing advice about the requirements of the Immigration Rules and whether you meet eligibility criteria
- Preparing and submitting the application on your behalf. We anticipate this will take around 4 hours.
- Attendance at a Home Office interview: if the Home Office asks you to attend an interview, we will give you clear advice (and discuss the possibility of us attending with you) at the appropriate time. This could be between 2 and 3 hours' work.
- Advising you on timelines and outcome of your application, and any further steps you need to take.

Once we have confirmed your instructions, we will provide you with a tailored fee estimate.

#### What is not included in the fee estimates above or fixed fee arrangements?

- These fee estimates do not include **disbursements** (costs related to your matter that are payable to third parties) or **expenses** (sums that we charge clients in relation to third party costs we incur in connection with undertaking your matter) please see the disbursements and expenses sections below.
- Additional time in respect of (i) large number of documents provided, and (ii) arranging interpreters or further evidence, and (iii) obtaining missing documents.
- Home Office fees.
- **Appeals**: If the Home Office reject or refuse your application, the fees estimates above do not include any advice or assistance in relation to any **appeal**. Typical fees for appeals and judicial reviews are £3000 £6000 excl VAT (£3600 £7200 incl VAT)

#### Disbursements (not included in the tables above or fixed fee arrangements)

You will be required to pay disbursements in addition to our fees. We handle the payment of disbursements on your behalf to ensure a smoother process. There are a number of possible disbursements payable to third parties in relation to our immigration services such as visa fees, healthcare surcharges and biometric charges - please contact us for an estimate of the disbursements that are likely to be relevant to your matter, as actual disbursements can vary

significantly between matters. Some examples of disbursements that may be incurred on you matter are set out below:

- Interpreters if required, interpreter's fees will be quoted separately. If you have a friend or family member who can assist with interpretation, please let us know. Hourly rates are usually in the region of £25 £90 plus VAT depending on language, notice, availability and working hours.
- Independent expert reports For example medical experts These are not usually required but we will inform you if we consider an expert report is necessary.
- Interviews if we attend an interview with you, expenses may be incurred in respect of mileage / travel expenses. We will let you have an estimate of such expenses before they are incurred.
- Home Office fees You must pay these disbursements to the Home Office directly as part of the application process, alternatively we can assist in facilitating payments. Please see the following link for Home Office fees <u>https://www.gov.uk/government/publications/visa-regulations-revised-table</u> Typical costs of Home Offices fees are the following:
  - Visa application fees: Variable based on application type.
  - Immigration Health Surcharge (IHS): Approximately £624 per year for most applications.
  - Citizenship application fees: £1,330 for adults and £1,012 for children.
  - Settlement (Indefinite Leave to Remain) fees: £2,404 per applicant.
  - Priority processing fees: £500 to £800 depending on the type of application.
- **Biometric Fees**: Approximately £19.20 (incl VAT) or £16 excl VAT per applicant.
- **Translation and Certification Costs**: Translation and certification costs depend on the number and complexity of documents. Below is an estimate:
  - Simple documents (e.g., birth certificates, marriage certificates): £50 £75 excl VAT and £60 - £90 incl VAT per document.
  - Complex documents (e.g., legal contracts, academic transcripts): £90 £150 excl VAT or £108 - £180 incl VAT per document.
  - Certification costs: Approximately £25 £50 excl VAT or £30 £60 incl VAT per document.

#### Counsel Fees

If it is necessary to instruct counsel (barristers) for advice, drafting, or representation at hearings, their fees will be charged in addition to our fees. Counsel's fees vary depending on their seniority and the complexity of the matter. Based on typical cases, we estimate counsel's fees as follows:

- Junior Barrister: £750 £1,500 (excl VAT) or £900 £1800 (incl VAT) for a oneday hearing or advice.
- Senior Barrister/QC: £2,000 £5,000 (plus VAT) or £2400 £6000 (incl VAT) for a one-day hearing or complex advice.

These estimates are subject to change based on the specific requirements of your case. We will provide a detailed fee estimate and obtain your agreement before instructing counsel

#### • Court or Tribunal Fees:

- For appeals or judicial reviews, costs range from £80 to £140 (VAT not applicable) (subject to case type).
- Refusal / Rejection of application

#### Expenses (not included in the tables above or fixed fee arrangements)

These are sums that we charge clients in relation to third party costs we incur in connection with undertaking your matter. You will be required to pay expenses in addition to our fees. Please contact us for an estimate of the expenses that are likely to be relevant to your matter, as actual disbursements can vary between matters. Some examples of expenses that may be incurred on you matter are set out below:

- Money transfer fees –
- This fee is often charged for processing and transferring funds during the transaction.
  - Estimated range: £20 to £60 incl. VAT (approximately £16.67 to £50 excl. VAT).
- Electronic Anti Money Laundering Search fee: This fee is for conducting AML checks required by law to ensure compliance. Estimated range: £15 to £50 incl. VAT (approximately £12.50 to £41.67 excl. VAT).

#### Factors that may impact our Legal Fees

The cost of our legal services and number of hours undertaken on your matter can vary depending on the specifics of your transaction. Key factors that may influence our fees include:

- The amount of supporting evidence we may have to consider
- The language(s) you speak and whether a friend or family member can be your interpreter. Interpreter's fees can be significant and are separately charged usually on the basis of time spent
- Whether you are applying with other dependents
- Provision of sufficient evidence at our first meeting which clearly meet the applicable Immigration Rules are likely to result in lower legal fee costs

# Timings

We will normally be able to submit most applications within two weeks from receipt of all evidence and information from you. In respect of complex transactions under the Tier 1 routes, applications can take much longer to prepare and submit.

We cannot guarantee the length of time the Home Office will take to process your application. Please see the following link for the current Home Office processing times - <u>https://www.gov.uk/guidance/visa-processing-times-applications-outside-the-uk</u>

However, the timeline indicated above can be affected by:

- Complex transactions under Tier 1 routes
- Issues identified during collation of evidence / documents from you
- Outstanding evidence / documents from you which have been requested by us
- Awaited expert reports (if applicable)

# **Key Stages**

- Initial consultation to understand your needs, assess your personal details and provide a fee proposal
- Eligibility assessment and advice review your qualifications against specific visa category requirements and advice on criteria to be met.
- Document preparation & review collate supporting evidence and ensure documents comply with Home Office standards

These first three stages are generally estimated to take 1 - 2 weeks

- Drafting and submission of application we will prepare and complete the appropriate Home Office application forms, conduct a thorough review for errors/inconsistencies and submit the visa application online or through the appropriate process. This is generally estimated to take a couple of hours as indicated above.
- Appointment scheduling & biometrics arrange for you to attend UKVCAS centre or visa application centre – 2 – 3 weeks after submission
- Communication with Home Office We will follow-up and monitor the application process and respond to any enquiries Home Office can take 6 12 weeks to process and in some cases 6 months.
- Decision & next steps Communicate the Home Office decision to you and provide a copy of the decision letter and provide further advice by explaining visa conditions, validity and next steps (e.g. obtaining a Biometric Residence Permit) or if the application is refused, advise on options such as reviews, appeals or reapplications.
